Under the National Model Work Health and Safety Act (WHS), **all organisations MUST consult with their workers** and may require a Committee involving Managers and Health & Safety Representatives (HSRs). These Committee Members must undergo a 5-day training course however this training is yet to be released. In the meantime, Representatives must still be trained. Recent prosecutions highlight the importance of WHS consultation, and both Companies and Individuals have been held responsible for these breaches under OHS/WHS Laws.
